Fair Share Investment Schedule

1. General Business, Service, Retail, Restaurant: \$50 base investment plus \$5 per employee with a maximum investment of \$150
2. Financial (Banks Credits Unions, etc.): \$124 base investment plus \$5 per employee with a maximum investment of \$300
3. Professionals (Dentists, Doctors, Attorneys, Insurance Agents, Real Estate Agents, Physicians, Morticians, etc.): \$50 base investment plus \$5 per employee with a maximum investment of \$150
4. Utilities (Electrical, Gas, Telephone): \$150 investment
5. Municipalities: \$175 investment
6. Churches, Organizations without facilities, etc.: \$30 investment
7. Health Care Facilities (Medical Center): \$500 investment
8. Assisted Living Center, Care Facilities, etc.: \$150 investment
9. Individuals: \$25 investment
10. Rental/Lease (Motels, Mobile Home Parks, Apartments): \$75 investment

For those businesses that do not specifically fit an established category, the Board of Directors will establish a rate comparable to other categories. Investments by new members are prorated per month to December 31st.
