## **Game Locations & Directions**

### **City: Crystal**

Game/Practice location: Lions Valley Place Park  
6822 32<sup>nd</sup> Ave. N.

Weatherline: 763-531-1184

Directions:

- A. From Hwy 100: Take 36<sup>th</sup> Ave exit west to Douglas Drive, Head south to 32<sup>nd</sup> Ave, Head west and the park building and rink will be 6-8 blocks up on the right hand side - (by sledding hill)
- B. From Hwy 169: Take 36<sup>th</sup> Ave exit east to Douglas Drive Head south to 32<sup>nd</sup> Ave, Head west and the park building and rink will be 6-8 blocks up on the right hand side - (by sledding hill)

### **City: Golden Valley**

Game/Practice location: Wesley Park  
8121 Wesley Dr

Weatherline: 763-512-2350

Directions:

- A. From Hwy 169 take Plymouth Ave to the east and proceed to Winnetka Ave N go north on Winnetka Ave N to Wesley Drive. Turn left (west) on Wesley Drive and park is two blocks from Winnetka Ave N
- B. From Hwy 100: take Hwy 55 west to Winnetka Ave N proceed north on Winnetka to Wesley Drive. Turn left (west) on Wesley Drive and park is two blocks from Winnetka Ave N.

### **City: Minnetonka**

Directions: From the intersection of 169 and 394, go south on 169 to Excelsior Blvd. Go west on Excelsior Blvd approximately 1 mile to Central Park/Hopkins Pavilion, 11000 Excelsior Blvd. The hockey rink is located just north of the Hopkins Pavilion.

## **City: Plymouth**

A. From 494 go west on Cty. Rd. 6 (approx. 3 miles) to Cty. Rd. 101. Turn right and proceed about two blocks. Entrance to the playfield is on the right (Oakwood Elementary School).

### Directions:

A. Take Hwy 100 N. to the 42<sup>nd</sup> Ave. N. exit. Turn right on 42<sup>nd</sup> and follow to Bottineau Blvd. (CR81). Turn right on Bottineau and proceed to 40<sup>th</sup>. Turn left on 40<sup>th</sup>, Sanborn Park is on the left side of the street across from Crystal Lake.

### Directions:
