Directions:

- A. From Hwy 100: Take 36th Ave exit west to Douglas Drive, Head south to 32nd Ave, Head west and the park building and rink will be 6-8 blocks up on the right hand side - (by sledding hill)
- B. From Hwy 169: Take 36th Ave exit east to Douglas Drive Head south to 32nd Ave, Head west and the park building and rink will be 6-8 blocks up on the right hand side - (by sledding hill)

Directions:
